

“The Weather Drawing Contest”

OFFICIAL RULES

NO PURCHASE NECESSARY

1. How to Enter: You can enter the Contest by sending a student’s drawing of any weather scene with student’s full name, school, grade, and scene being depicted to WGEM at 513 Hampshire Quincy, IL 62301. Submit individual entries with full name, grade and telephone number.

- **Entries must be received by January 12, 2017 at 5:00 P.M. for the January drawing.**
- **Entries must be received February 9, 2017 at 5:00P.M. for the February drawing.**
- **Entries must be received March 9, 2017 at 5:00P.M. for the March drawing.**
- **Entries must be received April 13, 2017 at 5:00P.M. for the April drawing.**
- **Entries must be received May 11, 2017 at 5:00P.M. for the May drawing.**
- **Entries must be received June 8, 2017 at 5:00P.M. for the June drawing.**
- **Entries must be received by July 13, 2017 at 5:00 P.M. for the July drawing.**
- **Entries must be received August 10, 2017 at 5:00P.M. for the August drawing.**
- **Entries must be received September 14, 2017 at 5:00P.M. for the September drawing.**
- **Entries must be received October 12, 2017 at 5:00P.M. for the October drawing.**
- **Entries must be received November 9, 2017 at 5:00P.M. for the November drawing.**
- **Entries must be received December 7, 2017 at 5:00P.M. for the December drawing.**

**All non-winning entries will be eligible for each monthly drawing.
Final date of entry is December 7, 2017.**

2. Eligibility: Open only to persons currently enrolled in elementary/middle school between the grades of Kindergarten and Sixth grade, who are legal U.S. residents residing in the WGEM, 513 Hampshire Street, Quincy, IL 62301 terrestrial geographic viewing area in the Adams, Brown, Cass, Fulton, Hancock, Henderson, McDonough, Morgan, Pike (IL), Schuyler, Scott, Warren (IL), Des Moines, Lee, Van Buren (IA), Adair, Clark, Knox, Lewis, Macon, Marion, Monroe, Ralls, Scotland and Shelby (MO) counties in Illinois, Missouri and Iowa, who are physically located and legally reside there in. Any individuals who receive the WGEM signal outside the terrestrial viewing area as described above (e.g. satellite transmission) are not eligible to enter the contest. Employees (and members of their household) of WGEM (Quincy Broadcasting Company) and employees (and members of their household) of Illinois Signal are ineligible to enter contest and cannot win prizes. Entries may not posses on computer or digital enhancement. One entry per individual.

3. Drawing and Notification: Winner will be randomly selected from all entries received prior to or on December 7, 2017. A WGEM Representative will contact the winning student and make arrangements to present the tablet and take the personal tour with a WGEM Meteorologist. WGEM reserves the right to change notification date without notice.

Winner will receive an LG tablet from Illinois Signal.

5. Winner Requirements: If winner cannot be available within three business days, WGEM may select another random winner from existing entries. Weather drawing winner tours will be offered between 10-11am and 1-2pm Monday- Friday. Except where prohibited by law, Entry and/or acceptance of any prize constitutes permission for the Contest Entities to use said winner's name, photograph, video tape, likeness, biographical information, statements, voice and address (city and state) for advertising/publicity purposes worldwide on and in connection with all forms of media (including but not limited to posting on the Web Site), now known or hereafter devised, in perpetuity throughout the universe without further compensation in connection with the sponsors, the Contest or the prize(s) awarded. Sponsors have the right to modify, use, assign and/or dispose of Entries however it sees fit and for any purpose without any notice or compensation to Entrant or any third parties.
